Drug abuse remains one of the most pressing public health and safety challenges facing our nation today. While law enforcement and rehabilitation efforts play a critical role, a proactive, large-scale media campaign serves as a powerful tool to prevent drug abuse by raising awareness, changing perceptions, and empowering communities to take action.

- 2. In light of the directions of the Hon'ble Union Home Minister a Nationwide Drug Awareness Campaign is proposed on 15-16 August 2025 to raise public awareness regarding menace of drug and mobilise support for drug control.
- 3. In this regard, a draft list of activities that can form part of a comprehensive nationwide media campaign aimed at educating, engaging, and inspiring individuals across all demographics is enclosed. These activities would include leveraging television, radio, social media, print, and community outreach to:

PESTB .

(a) Educate the Public to disseminate accurate information about the dangers of drug abuse, including the risks of opioids, synthetic drugs, and prescription medication misuse.

(b) Reduce Stigma by encouraging open conversations about addiction and recovery to foster supportive environments for those seeking help.

(c) Promote Prevention by targeting youth and vulnerable populations with evidence-based messaging to deter early experimentation.

- (d) Mobilize Communities by partnering with schools, colleges, healthcare providers, NGOs, and local leaders, sportspersons, lawyers and industry associations to amplify the campaign's reach and impact.
- 4. I request you for undertaking the suggested activities in your respective domain to significantly impact public attitudes and behaviours toward drug use.
- 5. The officers concerned may also be kindly advised to share the activities undertaken by them with local Press Information Bureau for wider publicity.
